New York State Joint Commission on Public Ethics plays a role in the operation of New York Government, promoting integrity by helping those in public service understand their ethical obligation. JCOPE: “*Violators are not prosecuted.*” Another toothless watchdog!

The Constitutional Convention was rejected by voters, but Chief Judge Janet Di Fiore has decided to work with legislation to enact reform in New York. (*Byzantine Court System, Susan DeSantis, 11/17/17*.)

The greatest glory lies not in never failing, but rising every time we fall. (Nelson Mandela) There comes a time when one must take a position that is neither safe, nor politics, nor popular, but he must take it because his conscience tells him it is right. (*Martin Luther*).

Taxpayers paid \$17 million in settlements over the past 20 years to settle claims by employees (268 settlements) against Congressmen. (*CNN Politics, 11/16/17*).

Not all Mother's Day cards use the word “mother” in an attempt to be transgender. (*Sun, 3/12/18*).

Do you know that killing a marine mammal in San Francisco, (a sanctuary city), can result in a \$100,000 fine and a year in prison, but if you kill a woman, you go free? This is a miscarriage of justice. The blame lies with Nancy Pelosi, Diane Feinstein and Jerry Brown who push for sanctuary city nonsense. (*Dec.3, 2017*).

The U.S. Tax Code has 4 million words. Every year Americans spend 6 billion hours and \$195 billion dollars trying to comply. In 2015, Americans called the IRS 56 million times with questions and 50% of the calls were unanswered. (*IBD, 12/4/17*).

Nearly three-fourths of the judges are not lawyers. People have been sent to jail or taken from their home without a proceeding. (*Propublica, 6/26/17.*)

The current administration has cut 22 regulations for every new rule introduced and cancelled or delayed 1,500 planned, regulatory actions. (*Washington-Free Beacon, E. Harrington, 12/15/17.*)

Some 3.5 million people are on election rolls that they are eligible to vote! Judicial Watch tabulates 462 counties where the registration exceeded 100%. Some counties have more than 62% more registered than living. California has 1.7 million ghosts. (*National Review, 8/11/17.*)

Bankruptcy Court is not a matter of bankruptcy trustees in collusion with corrupt judges (according to Attorney General John Ashcroft). *Lawyers Lie Under Oath*, by Sydney Sullivan, *5/14/14.* ALR has never met a trustworthy trustee!!!

Judge Alex Kozinski, 9<sup>th</sup> U.S. Circuit Court of Appeals, stepped down after 15 accusations of sexual misconduct. (*Fox News, 12/18/2017.*) (ALR suggests that judges and politicians be required to take the same test as police, i.e. Psychological and Physical).

30,417,609 people did not pay income taxes and received \$89,614,869,000 cash back from the Federal government called a "refund." (*Patriotpost, 12/20/17.*)

Joseph Percoco, Cuomo aide, (Executive Deputy Secretary), was convicted of soliciting and accepting more than \$300,000 in bribes. (*New York Times, 3/13/18.*)

Minnesota's Democratic Congressman, Keith Ellison, tweeted support for "Antifa" a terrorist group that promotes violence and rioting, a group funded in part by billionaire George Soros. (*Khandler Horn News, 1/4/18.*)

Governor A. Cuomo wants the controller to audit the Judiciary to certify that judges work eight hours a day. Judges would certify that courtrooms remain open till 5:00 PM to cut backlogs. (That's easy; just walk the halls.)

The National Center for State Courts publishes the Judicial Conduct Reporter, [www.ncsc.org](http://www.ncsc.org).

Staten Island whistleblower-clerk accused Judge of colluding with Staten Island District Attorney to divert cases away from Defendant-Friendly Courts. He had taped conversations. (*New York Law Journal, 12/14/17.*)

In California, a prison dentist earned \$838,000/year total wages. In New York City, a retired sanitation worker earned \$285,000. (*Google*)

Switzerland's law requires that everyone own a gun and maintain marksman qualifications. There are NO MURDER OCCURANCES IN SWITZERLAND.

Chicago saw 762 murders, 3,550 shootings, 4,330 victims in 2016. Guns are outlawed in Chicago, the highest in 19 years. (*CNN, 1/2/17*)

An insurance company (Silver Script) provides assistance for its clients in 65 languages and phone numbers to comply with Federal Civil Rights Law (2017).
